

First Visit, November ???

Robert opened with "I know who you are. He said that I have talked to a lot of people and I got all the information....alluding to me to not avoid answering cause I know everything ....and I said ...that' s good....and he said I know everything...I know how many times barbara has come to see you and how much money she spent and she sent all of her friends to you and you are the big ring leader...and alluding that I am like some kind of a stud...and I laughed and said I am 70 years old...you got to be kidding me...and I looked at the girl and said...are you guys for real...and he said ....well I want to know what your charm is. ....and told him I am on nine medications and I don't' remember everything....and he said....Oh...so now you are under Doctor supervision, huh?...and I said I was...and he said....Oh...you don't remember...he said a lot of things that were intimidating and he was acting more like he was some kind of criminal investigator. "Once I let him in the house, he got very specific about his questions 1) Do I know a man named Uri? He did not have photo id nor fingerprint on his CA investivative card and I thought that from the beginning that it was fraudulent.

This was intimidation....he stepped over the line in my opinion...to a novice this man would have scared the wits out of you....he comes off pretty serious.
