4 PM

RECEIVED PHONE CALL AT WORK (300 OLD NISKAYUNA RD. LATHAM, N.Y. A. GABRIELLE STUDIO HAIR SALON) FROM AN UNIDENTIFIED WOMAN ASKING "HOW LATE ARE YOU OPEN FOR APPOINTMENTS?" I RESPONDED, "TILL 9PM, ARE YOU INTERESTED IN MAKING ONE?" "NO" SHE SAID "I'LL GET BACK TO YOU".

8PM

MAN (LATER IDENTIFIED BY PICTURE ON WEBSITE) STEVE RAMBAM AND WOMAN ENTER SALON. I WAS WORKING ON CLIENTS AND SAID "HI, CAN I HELP YOU?" HE SAYS "WE'RE INVESTIGATORS" I SAID "WHAT CAN I DO FOR YOU" HE SAID "WE WANT TO TALK TO YOU"

I SAID "I'M NOT INTERESTED IN TALKING TO YOU"

HE SAID "YOU'LL BE VERY INTERESTED IN WHAT WE HAVE TO SAY."

I SAID "IF THIS HAS ANYTHING TO DO WITH NXIUM, I'M NOT INTERESTED IN TALKING TO YOU"

HE SAID "WE DON'T WORK WITH NXIUM"

I SAID "I'M VERY BUSY AND I DON'T WANT TO TALK TO YOU"

HE SAID "WE CAN WAIT"

I SAID "I HAVE AN HOUR LEFT OF WORK AND I DON'T WANT TO INTERRUPT MY CLIENTS SERVICES"

HE SAID "OH WE'LL WAIT".

I SAID "AT THE END OF THE HOUR, I'M TAKING MY SON HOME TO BED (WHO WAS ALSO IN THE ROOM WITH MY 2 CLIENTS AT THAT TIME) AND I'M NOT INTERESTED IN TALKING TO YOU".

I THEN SAID "YOU CAN COME BACK IF YOU WANT"

HE SAID "GOOD, WHEN?"

I SAID "TOMORROW, 10AM"

NOV. 12

4 PM

STEVE R. AND THE WOMAN CAME BACK TO THE SALON AND I WAS INSIDE WITH DOORS LOCKED. I DIDN'T ANSWER. THE LIGHTS WERE MOSTLY OUT AND NO ONE ELSE AT THE SALON.

NOV. 22

3 PM

RECEIVED A MESSAGE AT HOME FROM DAZZLE EKBLAD SAYING "HI ANG, IT'S DAZZLE, CAN YOU CALL ME AS SOON AS POSSIBLE, IT'S IMPORTANT.

I CALLED BACK AND LEFT A MESSAGE.

6PM

SHE CALLED ME BACK AND SAID "I WAS CALLING BECAUSE I HEMMED AND HAWED AND WAS VERY RELUCTANT TO TALK TO THIS INVESTIGATOR....BUT I FINALLY DECIDED TO DO IT BECAUSE YOU KNOW I DON'T WANT TO GET DEPOSED FOR ANY OF THIS LEGAL STUFF, AND I DON'T WANT TO GET DRAGGED INTO COURT. HE ASSURE ME THAT THIS WOULD HELP ME" HE SHOWED ME THE LETTERS THAT YOUR NAME WAS SIGNED ON AND IT LOOKED LIKE A DEMAND FOR MONEY, AND HE TOLD ME IT WAS EXTORTION....AND I WAS WONDERING WHAT YOU WERE THINKING..?

I'M CALLING BECAUSE I MET WITH THIS INVESTIGATOR, STEVE RAMBAM, TODAY AND HE'S INVESTIGATING SOME OF THE THINGS THAT ARE GOING ON....AND YOU KNOW... HE WAS TALKING ABOUT, YOU KNOW, HOW YOU COULD BE WRAPPED UP IN ALL THIS AND END UP GETTING ARRESTED AND I REALLY DON'T WANT THIS TO HAPPEN TO YOU.

4pm: Received phone call at work (300 Old Niskayuna Rd. Latham N.Y. - A. Gabrielle Studio Hair Salon)
From an unidentified woman asking "How late are you open for appointments?" I responded, "till 9pm, are you interested in making one?"
"No" she said "I'll get back to you".

8pm: Man (later identified by picture on website) - Steve Rambam and Woman enter salon. I was working on clients and said "Hi, can I help you?"
He says "We're investigators"
I said "What can I do for you?"
He said "We want to talk to you."
I said "I'm not interested in talking to you"
He said "You'll be very interested in what we have to say."
I said "If this has anything to do with NXIVM I'm not interested in talking to you."
He said "We don't work with NXIVM."
I said "I'm very busy and I don't want to talk to you"
He said "We can wait"
I said "I have an hour left of work & I don't want to interrupt my clients services"
He said "Oh we'll wait"

I said "at the end of the hour I'm taking my son home to bed (who was also in the room with my 2 clients at that time), and I'm not interested in talking to you."

I then said "you can come back if you want."

He said "good, when?"

I said "tomorrow, 10 AM."

Nov. 12th

4pm. Steve R. and the woman came back to the salon and I was inside with doors locked. I didn't answer. The lights were mostly out and no one else at the salon.

Nov. 22nd.

3pm. Received a message at home from Darzele Ekbioud saying "Hi Ang, It's Darzele, Can you call me as soon as possible, It's important!"

I called back and left a message.

6pm: She called me back and said "I was calling because I hemmed and hawed and was very reluctant to talk to this investigator... but I finally decided to do it because you know I don't want to get disposed for

any of this legal stuff, and I don't want to get dragged into court. He assured me that this would help me." He showed me the letters that your name was signed on and it looked like a demand for money, and he told me it was extortion.... and I was wondering what you were thinking..?

I said "Dazzle, we were requesting our pay checks and monies owed to different people" they responded with a legal letter to not contact them without legal representation" we did that and they have not responded."
